



◎管理公司体系结构图


Manage company structure chart

At present, the company has many excellent captains and many chief engineers. At the same time, the company will build a highquality crew team with the spirit of "diligence, sureness, devotion to work".











- 1. 除了严格控制采购流程可以降低船用品成本外,德威船务管理公司一直跟踪主要备品的价格变动,了解产品在不同国家和区域的最低价格,进货时综合比价,严把质量关,随着船队数量的增大,和销售方谈判能力还会进一步提升。比如润滑油、油漆、主要机器备件、图书资料等这些用量大的产品,尽可能地和供应商保持长期的合作,掌握这些产品的真实价格。
- 2. 船舶检验费、维修费等也是主要管理成本之一,不同的船级社和修船厂在价格方面和质量方面有不小的差别。船东要控制这方面的成本必须全面了解各家船级社和船厂方面的情况,建立长期的合作关系,从实际船况和经营规划出发,做好各项检验、维修的安排工作。选择合适的检验、维修地点,专业的技术人员在现场严格把好质量关是控制这方面成本的关键。
 - 3. 通过合适的保险经纪人,做好保险规划,把钱用在刀刃上。
- 4. 严控隐形成本。隐形成本主要包含海损、机损和人员伤亡事故,还包含因为检查或其他责任事故引发的损失,例如停租、油耗索赔、额外的检验、管理质量评分低在租约方面的损失等,这些对船舶经营正常获利有负面作用的事件或者因为发生事故造成的保险费率提高等都是间接损失。我司在管理方面一直实行严格的高品质管理,想船长、老轨所想,在关键节点上有针对性地对船舶进行指导,历年的事故率在行业保持最低,平均每年每条船的停租时间小于 1 小时。不仅仅在租金方面避免了损失,而且在保险费率方面赢得了最优惠待遇,在低迷的租船市场仍然保持较高的租金水平,船舶的日均管理成本在国际国内上来说,都算得上是最低的管理公司之一。可为船东节省一笔非常可观的管理成本。

Ship operation cost control

- 1. In addition to strictly control the purchasing process can decrease the cost of ship goods,, shipping management companies have been tracking the main spare parts price change, understanding the lowest price of product in different countries and areas, comprehensive comparison when replenish onr's stock, strictly the quality pass, the increase in the number of ships, will further enhance seller and negotiation ability. For example, for lubricating oil, paint, main machine spare parts, books and materials and other products with large consumption, keep long-term cooperation with suppliers as far as possible, and master the real price of these products.
- 2. Ship inspection fee and maintenance fee are also one of the main management costs. There are considerable differences in price and quality between different classification societies and repair yards. In order to control the cost in this aspect, the shipowner must have a comprehensive understanding of each classification society and shipyard, establish a long-term cooperative relationship, and proceed from the actual ship condition and business planning to do a good job in the arrangement of inspection and maintenance. The key to control the cost is to select the proper inspection and maintenance site and strictly control the quality by professional technicians.
 - 3. Plan your insurance through the right insurance broker and put your money to good use.
- 4. Strictly control hidden costs. Hidden costs mainly include average, machine damage and casualties accident, also contains for inspection or other liability accident loss, such as offhire, fuel consumption claims, additional inspection and management quality score low in terms of the lease, such as the loss of these events has negative effect on normal operation of profit or because of an accident insurance rate increase is caused by indirect losses. In terms of management, our company has always implemented strict high-quality management, and guided the ship at key points according to the captain's and old rail's ideas. The accident rate in the past years has been kept at the lowest level in the industry, and the average stopping and renting time of each ship is less than 1 hour every year. Not only did it avoid losses in terms of rent, In addition, it has won the most preferential treatment in terms of insurance rates and maintained high rents in the depressed chartering market The daily average management cost of ships is one of the lowest in the world and in China. Can Save shipowners a very considerable amount of management costs.
